### Maintenance and Care

While applying lubricant to your Wally Marshall™ reel, avoid using multi-purpose oil. Use lightweight silicone based oils or greases made for fishing reels. Apply oil to all bearings, the crank shaft, and the worm gear. Apply grease to the bushings, pinion gears, drive gears, and crank gears.

After usage your reel should be inspected for dirt or sand and cleaned if excessive buildup is present. If your reel has come in contact with saltwater it is important to flush all parts with water, dry and re-lubricate your reel. Through diligent cleaning and maintenance your Wally Marshall™ reel will provide you with years of reliability and sound performance.
